# **HIGH-LEVEL POLITICAL FORUM 2023**

## **Key Message for 10YFP Progress Report**

This is the progress report on the 10-Year Framework of Programmes on Sustainable Consumption and Production Patterns (10YFP). This report has been prepared by the United Nations Environment Programme, acting as the Secretariat of the 10YFP. It builds upon an annual reporting mechanism for Member States and stakeholders. The report fulfills the purpose of updating Member States and stakeholders on the progress made in 2022 regarding the implementation of the 10YFP. The progress is based on the official reporting of Member States on SDG 12.1. Furthermore, the report introduces the Global Strategy on Sustainable Consumption and Production (SCP) for the years 2023 to 2030. It also highlights updates in the initial implementation of the Strategy during 2023.

- **01.** Sustainable Consumption and Production can act as a vehicle to address the triple planetary crisis and support a sustainable recovery.
- **O2.** The Global Strategy for Sustainable Consumption & Production provides a coordinated, cross-cutting and targeted response to the challenge of shifting patterns of sustainable consumption & production globally and must be **embraced**.
- **O3.** Circular economy principles are increasingly being adopted by countries as a central vehicle to achieve sustainable consumption and production, but levels are too low and further implementation must rapidly accelerate.
- **04.** We must **intensify multilateral and multi-stakeholder collaboration** to accelerate **coordinated action** for sustainable consumption and production in the context of the implementation of the SDGs.
- **05.** An inclusive approach focusing on gender equality and uplifting vulnerable communities is key to achieving sustainable consumption and production systems.

- **06.** To accelerate the shift towards SCP we must **focus** our attention on **high impact**, **industry sectors** and ensure they are significantly reducing their negative climate, biodiversity, and pollution footprints
- **07**. Realizing collective climate, biodiversity and pollution goals requires sustainable consumption and production & circular economy to be embedded within multi-lateral environmental agreements (MEA's)
- **08.** Harnessing the potential of emerging digital technologies and tools is key for accelerating the transition to a digital technologies circular economy.
- **09.** It is essential that we ensure that people everywhere have **relevant information on sustainable lifestyles** that exist in harmony with nature
- 10. **Policies** that can effectively **drive behavioral change** towards sustainable outcomes need to be prioritized as a matter of urgency



## ISO Endorse China Environmental Labeling Program as A Typical Case of Conformity Assessment Conveys Trust



Lately, at the "2023 Conformity Assessment Service Trade Facilitation Forum" of the China International Fair for Trade in Services, the International Organization for Standardization (ISO) "Conformity Assessment Convey Trust for Industry Chain" of Chinese version and promotional video were released which China Environmental labelling Program was endorsed as a typical case.

China Environmental Labelling Certification commits to advocate consumption, selection, promotion of environmentally friendly technologies and products, and promote green consumption. Since the implementation of China Environmental Labelling program, more than 130 standards have been issued, and more than 7,000 enterprises have been certified, involving more than 300 products categories, and the number of certified product models has exceeded 2 million, covering all aspects of consumer life such as automobiles, clothing, household, electronics, and daily chemicals.

Since 2006, the certification results which under the participation and implementation of China Environmental United Certification Center (CEC)., have been adopted by government green procurement, which has laid a positive role in leading the green production and consumption transformation.



# **GPN Launches Sustainable Goods and Services Website**

In September 2023, Green Purchasing Network (GPN) launched a new website for sustainable products and services.

GPN has collected and provided environmental information on more than 13,000 products through "Eco Products Net". In addition to "Eco Products Net," GPN has launched the "Sustainability Products Service" website as a feature page for products that seek sustainability, taking into consideration not only environmental aspects but also social aspects (legality and sustainability of raw materials, human rights and safety of producers in the raw material producing areas, etc.).

The first issue features "yuimori" from Kokuyo Co., Ltd. and "recycled ink cartridges" from Ecolica Co. The "yuimori" product utilizes thinned Japanese cypress and beech wood to help conserve forests and revitalize local communities, while the "Recycled Ink Cartridge" product contributes to the spread of products made from recycled plastic (production and sales of environmentally friendly products) through the establishment of a collection and circulation system (procurement) for used ink cartridges. The "Recycled Ink Cartridge" is a product that contributes to the spread of products made from recycled plastic (production and sales of environmentally friendly products) through the establishment (procurement) of a recycling system for used ink cartridges.

For the 30th year, TGL has developed more than 126 criterial and certified for more than eight thousand models form the product group of office supplies, construction equipment, electrical appliances, automobiles, paper, clothes, furniture, cleaning products as well as cleaning service, etc.

In addition, a ceremony was held to present honorary plaques to companies that have received the Green Label certification for over 20 consecutive years, with 8 companies receiving the award as follows:

The SEAA serves as a crucial platform for acknowledging and celebrating the efforts of businesses and organizations in Singapore that prioritize environmental sustainability. By expanding its scope to include SMEs, it not only recognizes their substantial contributions but also encourages more entities to adopt eco-friendly practices. In the pursuit of a greener, more sustainable future, the SEAA continues to inspire and set a benchmark for environmental achievement in Singapore and beyond.

# **IGPN** Intiative Update

# Green Purchasing Network Measurement Methodology Development

<u>The initiative of Green Purchasing Network(GPN) measurement methodology</u> <u>development was launched this June during the of IGPN 2023Knowledge Sharing webinar.</u>

This initiative initially proposed by Mr. Chair, intends to formulate a kind of measurement methodology by summarize the GPN model, and fulfill the IGPN mission implementation by promoting GPN practice through this measurable, reportable, and replicated methodology.

The duration of this initiative is 2 years from 2023 to 2024 and it is initially implemented in IGPN members. the planned output will include:

- A measurement methodology with feasible access of GPN definition, qualitive and quantity monitoring indicators;
- · An excel calculator guide the pilot testing of the methodology;
- A pilot testing report of the methodology which brough performance overview of each Green Purchasing Network with recommendations

Based on the first batch collective suggestion, the < Measurement methodology for Green Purchasing Networks (Version 2.0) > has been revised by the Secretariat, based on the suggestions and comments provided by IGPN members including GPN Japan, GPN Malysia (GPN BERHAD), GPN Thailand (Thailand Environment Institute), GPN Singapore (Singapore Environment Council), GPN China (China Environmental United Certification Center) and Green Council.

Now the second batch for soliciting suggestions is under going! The scope for calling for contribution is extended to the external professionals from One Planet Network SPP program, and the timeline will be till 31st October.
