

Partners of the SPP programme came together for a collaborative workshop to identify key area of focus to support national SPP implementation. Given that the programme's ultimate target group is procurement practitioners, governments and moving forward, the programme will target the challenges procurement practitioners face in their day-to-day efforts. The SPP programme 2019-2022 strategy document is currently being finalized and its endorsement is expected along with the establishment of the new co-leads of the programme.





Experiences from road testing the Guidelines for Providing Product Sustainability Information

The report 'Ready to Drive the Market: Experiences from Road Testing the Guidelines for Providing Product Sustainability Information' was launched at a side event at the United Nations Environment Assembly in Nairobi, and on Tuesday in a global webinar. Among those testing these guidelines are GEN Members GreenPro and TÜV Rheinland, and GEN Chairman Bjørn-Erik Lønn was a part of the working group who produced the guidelines.



## **IGPN Secretariat is launched in Beijing**

The International Green Purchasing Network (IGPN) Secretariat was launched in Beijing on November 26, 2018 at the "Capacity Building Project on Typical Green Products in APEC Economies—Workshop on Ecolabel and Green Consumption". Witnessed by all the participants and international experts of the workshop, IGPN Chairman Mr. Hideki Nakahara officially handed over the Letter of Authorization to Ms. Zhang Xiaodan, General Manager of CEC.

The handover of IGPN Secretariat to CEC obtains the approval of Ministry of Ecology and Environment as well as agreement of IGPN Council, Advisory Committee and all its members. The Secretariat will give full play to the role of IGPN; continuously facilitate green purchasing in public authorities and business sectors; actively promote green production and green consumption; promote green and win-win regional development and contribute to the achievement of UN Sustainable Development Goals.

- Designing and providing a self-evaluation checklist for businesses to promote sustainable procurement through their products, services, and supply chains.

Ekonnect Knowledge Foundation conducted a 5 days training program for the officials of the Department of Environment (DoE), Government of Bangladesh between March 25 to 29 in Mumbai. The training program covered topics such as air quality and stack emissions monitoring, air quality data analytics, air quality modelling with AERMOD, Inspection and Audit of Industrial Facilities and Auditing of EIAs. Field visits were organized to CETPs and Haz Waste Storage, Treatment and Disposal facilities, continuous air quality monitoring station and Environmental Information Centre at Maharashtra Pollution Control Board.
